## Booth Fees & Application Deadline

- **Vendor booth rental fee:** \$40 per 10' x 10' space    1 Month\_\_\_\_ / 3 Months\_\_\_\_
- **Discounted rate:** \$35 per month when paying for three months in advance (\$105 total)
- **Food trucks and food vendors** must obtain a permit from the **City of Duncanville**.
- **Applications and payments must be received by 5:00 PM on the Wednesday before the market** at the Duncanville Chamber of Commerce.

## Market Details & Vendor Requirements

- Duncan Switch Market seeks vendors offering **arts, crafts, plants, produce, food, resale items, services,** and other items, **at the discretion of the Duncanville Chamber of Commerce.**
- Market hours: **9:00 AM – 3:00 PM**
- **Check-in and set-up:** Begins at **7:00 AM**
  - Check in at the **Duncanville Chamber tent** at the front of the vendor area.
- Vendors must be fully set up and ready for business by **8:45 AM**.
  - **Food vendors must be ready by 8:30 AM.**
- Vendors are responsible for leaving their spaces **clean and free of debris.**
- **Electricity is not provided.** Vendors must bring generators if power is needed.
- Vendors must supply their own **tables, tents, chairs, display units, and equipment.**
- Vendor spaces are assigned on a **first-come, first-served basis.**
- **Food trucks** will be permitted to set up at the end of **James Collins in the cul-de-sac** and must have an **approved City of Duncanville permit.**


# Vendor Agreement & Release
